The adopting guardian moreover undertakes to have the dog sterilised (if applicable) by a registered Veterinary Surgeon within \_\_\_\_\_ month(s) of taking guardianship and a copy of the sterilisation certificate issued by the veterinary surgeon will be made available to TRANQUILITY RESCUE CENTRE by means of post, fax or email to the contact details as supplied. Failure to comply with the sterilisation of the dog will result in the dog/s being returned to the adopting agent.
5. The adopting guardian undertakes not to chain \_\_\_\_\_ and \_\_\_\_\_ and to ensure that the dog/s receives the necessary annual veterinary vaccinations.

6. The adopting guardian undertakes not to dispose of, sell or give the dog/s \_\_\_\_\_ and \_\_\_\_\_ to any person without the prior written consent of TRANQUILITY RESCUE CENTRE. The adopting guardian undertakes to return the dog/s to the care of TRANQUILITY RESCUE CENTRE should he/she decide not to keep them or be unable to care for them for the rest of the dog/s natural life-span. Under no circumstances are the dogs to be “donated” to an SPCA or Welfare Centre. Failure to comply with this clause will result in legal action.
  
7. TRANQUILITY RESCUE CENTRE will have the right to inspect the premises of the adopting guardian from time to time to ensure that the terms of this agreement are met.
